Approval of Minutes

Old Business

• Update on retaining wall repair at Adriatica – scheduled for 4th Qtr. 2022

New Business

- Mary handed out a new L&G/Grand Manors contact list
- Mary stated we may have a possible new member she emailed them on how to apply
- A request from homeowner in Mayberry Park for the planting of watermelons at their gazebo. Discussion included that this would require additional work by our LMC's, additional watering as well as other items. Mary will email Grand Manors for them to inform the homeowner of the committee's decision.
- Spring Hill entrance beds homeowner has contacted us again as to when they will be done. This item is currently on our list as a priority 3 item however, it should be done when the spring plantings are done. Gerard will get an updated estimate for this project and once received we will do a cyber vote for approval.
- Banner seasonal change this item is already currently being handled by Grand Manors.
- Landscape Vendors contract extensions Both Manders and Superscapes is willing to do the additional 2-year extension. They had both asked that they would like to meet

with the committee to see what our expectations are. The committee has asked that Gerard get with Ed at OLM concerning the contract extensions for his advice.

- Currently the only watering that is currently being done is the plant beds and the turf watering will begin the 1st part of May or earlier if needed. Mary stated that she asked that SOS consider adding wind delays on watering when necessary.
- Parkwood issues with trimming needed in greenbelt It was discussed with what happened with homeowners interfering with tree work needed in the greenbelt. Jim Buerkle will write up a policy on how items such as this will be handled. He will email it to the committee for their approval. Upon the committee's approval he will then present it to the Board of Directors.
- Ridge tunnel flooding issue this item will be discussed at the upcoming special meeting on budget items.

Update from Board Liaison

- The Board of Directors is currently working with Grand Manors on receiving timely finance reports.
- Irrigation repairs on what is being done now and what will be done in the future.
- The Board of Directors discussed complaints about what homeowners can and can not do in the common areas of SBR.
- The Board of Directors is combining the organization meeting with the board meeting

Gary Lauman presented the current list of what has been done on the Area C Hardscape Tour. This area has many monuments and columns and not all have been completed. The committee will need to get estimates on the items and will need to prioritize what will need to be completed in this year's budget. There was on monument that is much need of immediate repair, Gerard will get with Tejas so that we can get an estimate of repair.
