



Fencing/retaining walls between lots is equally shared by the two property owners. The following shows agreement by both neighbors to the fence/retaining wall replacement/move/alteration.

Privacy Fences: Maximum height of 6 feet, can be Cedar or Redwood Side by Side with Trim Cap or Board on Board, and stain must be of muted earth tones in the brown or gray range. **Metal Fences**: Black Wrought Iron, 59" in height, view Design Guidelines for approved style, and can have 18" dog bars.

<u>Retaining Walls:</u> Requires a licensed Professional Engineer report, stone only (Milsap or Brown Hacket), and shall not alter or impair the drainage across adjacent properties.
