Update Discussion

Action: Board Liaison Amanda Batson and Communications Director Susan Spoonemore reviewed progress on New Homeowner Brochures. Brochures were mailed to 254 new residents in December from the back half of 2022. Brochures were also sent to Committee members for review.

Agenda Item: SRCA IT & Digital Initiatives

Action: Executive Director Brian Matt provided an update on IT initiatives. Website has been moved to a new host. We now have a month-to-month agreement with a company that

is providing day-to-day security monitoring.

Action: Brian and Amanda reviewed the need for digital tracking of amenity use. The Amenities Committee has recommended using ACTIVENet, which could provide scannable ID cards. Committee member Maneesh Moota noted a need for mobile cards as well. Rollout timing proposed to start in February with ramp up to pool season.

Agenda Item: Video Strategy

Action: Amanda spoke to the recently established video strategy sub-committee of Susan and Committee member Sally Huggins. Will provide monthly updates to the Committee. Susan stated that 5 strong video production company candidates have been identified, with appointments set with two thus far (first on 1/6). Focus on companies with HOA and real estate experience.

New Business

Agenda Item: New Homeowner Orientation

Action: Discussion – Brian discussed the need for smaller, "by invitation" events. Potential format for such events includes wine and light hors d'oeuvres with orientations held at the Community Center for around 50 attendees per event. Presentations would include an overview of amenities and events. Committee member Allison Pitts recommended adding a childcare component to increase attendance.
