### **Approval of Minutes**

- Status of Plainfield (sidewalk repair and erosion) The City of McKinney still has not completed the sidewalk repair.

### **New Business**

- One lot from Emerald Heights has been annexed by Stonebridge Ranch.
- 2 Board of Directors up for re-election this year, but elections will not be held at the Annual Meeting.
- o A rowing club is to be formed in Stonebridge. Guidelines will be established.
- o PRS project in areas A and B was reduced. Area C will be looked at later in the year.

Norm Counts reported that during the transition of management companies there were changes made of guidelines of SBR. Asset policies were missing. Reserve study needs to be made every 3 years. A useful handout was given about asset management board guidelines and explained.

Amanda Griffin reported that Millard Pond will be dredged. The construction company will cut and cap the lines and replace after dredge.

Janie Lopez went over the L&G Budget Forecast Items. She is still working on updating the estimates and no projects currently need committee approval.
