No Fall plantings for 2024

- Mathew, Matthew, and Aaron will meet to go over plant list for sunny and shade beds. Committee to meet 05/23/24 at 9:30 am to discuss plant material to be used.
- Care and treatment map addressed of areas A, B, C & D. Area D is wildflowers for native area. Area C is in greater need.
- Updated irrigation map and test controllers. Testing zones to see what works. Making master map for controllers.
- Gary and Mathew will conduct a Hardscape tour of area C and review area B on May 15 at 8:00 a.m.
- Iron Fence Tour Mathew needs to complete list.
- Color bed and irrigation analysis RFP Mathew is still working on.
- Contract RFP update Mathew working on a mowing and chemical treatment schedule.
 Pre-bid meeting is scheduled for June 7th.
- Mathew met with the City of McKinney. Medians are 100% SBR responsibility. They
 need to be watered the same as all SBR. Tunnels lights and power is the responsibility of
 the city.
- Homeowner issues:
 - 624 Rough Creek homeowner wants the fence removed temporarily so they can repair brick wall. Homeowner will need to do repair to wall as per our engineer specifications.
 - 1800 Camberton Drive The committee previously approved however the BOD denied. Mary Patrick made the motion to readdress this issue with the BOD.
 Matthew Skor seconded, and the motion carried.
 - Drain Line Issues Mathew found information from State of Texas level law and SBR CCR's. Homeowner needs to be cited to fix their drain lines that are on our property.
 - Lake Point HOA Hardscape Issue inside the HOA sub division is our responsibility. They did not care for our tree or wall properly. Mathew will update committee later.
 - Ballantrae Meeting Update the subdivision is not happy concerning monument lighting, lack of mulch and clean up of plant material. Eric to repair monument lighting.
- Operation Budget Financials The committee reviewed, irrigation summary is under budget and the landscape contingency it not yet completed.
- Matt Skor made motion to address the BOD for Mathew Roebuck to have an assistant. Mary Patrick seconded the motion, and the motion carried.
