• Contracts on Beach Club pool are being studied.

- Board reviewed budget and suggested cuts.
- A new GM candidate is possible.

Mathew Roebuck

- Stated that mulch in playgrounds is Amenities responsibility.
- Instead of ongoing projects, make plans to finish what is already started.
- Ballantrae sidewalk and sinking ground needs to be fixed. Soil needs to be filled in even with sidewalk for safety issues. High profile areas need completing.
- Reserve spending updates Cascades' Pond needs to be fixed but cannot proceed until homeowners fix their part.
- Color beds are prepared and ready to plant for sections A & B. Section C currently on hold until a landscape contractor is selected.
- Mulch reduction is finished on Section A and B.
- Pre-emergent tests are being done on Section C.
- Fountain View Section C was seeded and did well. Needs to be reseeded before seasonal rains begin.
- Mathew believes erosion projects should be handled first.
- Landscape contracts 2025 are being held up because lawyers feel that more contracts need to be presented to Board but cannot move forward because of lawyers.
- Mary tabled discussion of contracts at this time.

Landscaping inspection reports were emailed to committee members.
