New Business:

Jim Buerkle – Board update

Discussed the 2025 budget

- Reviewed the 2025 Reserve budget.
- Board created a group for pool construction and updates. Jim Buerkle will head the group.

Mathew Roebuck – L&G updates/reports

- Introduction of the new General Manager for Grand Manors Kris Grooms.
- In process of hiring an assistant for Mathew. There were two candidates, and one was selected and is currently going through new hire paperwork.
- Contracts were given to Manders, Section B and Superscapes, Section A&C.
- Discussion of the seasonal color bed project.
- Old McGarrah Cemetery: City violation sent Oct 17, 2024. Needs clean-up and tree
 work. There is no access as the gates are locked. Review of ownership is needed. Collin
 County History Commission says cemetery is not ours. City has deed to SRCA and
 developer in 1988.
- Homeowner, Ramon Molina of 8200 Rayburn Lane, claims water runs from Fountain
 View soccer field run off kills lawn and has potential foundation issues. Several variables require further reviews and analysis. Suggest that homeowner needs to install grass.
- Bridgepoint sub-association Management and Homeowner, Amy and Rick Williams, are concerned of monuments failing and requested meeting. Concerned monument missing plant material and seasonal color and median missing a magnolia. Was explained remedies were not in budget this year. Needs to wait until new plantings in 2025.
- Eagle Creek and Canterbury Monument has deteriorated since 2023 inspection.
 Homeowners' concerns reported. Recommendation: Increase irrigation and meeting with Tejas Stone Works for rebuilding or repair as needed.
- Mulch reduction plan:
 - Section A: Completed Lake Forest Drive Villages: Arbor Glen, Arbor Hollow, Briar Ridge, Hills Creek.
 - Section B: Stonebridge Dr. completed from Custer to Aquatic Center. Fieldstone
 Place and Coronado Village approved to do.

Landscaping inspection reports will be emailed to committee members.
