New Business:

Jim Buerkle - Board Updates

- Jim Buerkle is back on the Board of Directors and is still our liaison.
- Winners of the door prizes from the Annual Meeting will be announced.
- Board approved new member, Karin Gerace.

- A board member complained about water costs. Only options are seasonal rates or stairstep rates but neither would work for Stonebridge Ranch.
- Collection reports there are many outstanding debts not paid.
- Eric Ortega gave extensive report on the Aquatic Center and the pool is going to be replastered.
- Cost for members at Apex Center reduced cost for SBR members.
- Beach Club survey votes were mailed out. There will be a delay on pool plans as it is going back to the designers and contractors. Special assessments decided on by late summer or 2026. Pool may open by 2027.
- Special Committee stated wine tasting will have a cost since by law food must be served at the event.

Mathew Roebuck – L&G Updates/Reports

- 8712 Brunswick Lane Homeowner issues with proactive events about trees and
 erosion in a tree preservation zone. One tree removed because of storm damage. Riprap
 was installed and there was no erosion and area is currently stable. Letter being sent
 out saying problem will be fixed but timeline is stated. We will take back control of the
 watering of the common areas.
- Wellington Pond Repair Plans to fix 2 and 5 for erosion.
- Wellington Point Homeowner claims we lowered his fence 3 inches. Will need to talk to Compliance Committee before going forward.
- Operating Budget Review -
 - Under on mulch but over on landscape.
 - Color reduction planted Purple Heart on Section A.
 - Aeration will be completed before summer.
- Tunnel erosion reserve projects. Two tunnels will match with landscape. Projects are almost complete.
- Request irrigation report wrote Board letter of back repairs. Still looking for leak.
- Monument on Virginia and Stonebridge may go ahead with our insurance to repair.

Landscaping inspection reports will be emailed to committee members.
