The Stonebridge Ranch Community Association Board of Directors finalized a formal partnership with landscape architecture firm, Kimley-Horn, to lead the design and development of a modernized amenity for our owners. In 2025 there will be opportunities for homeowners to learn about the design, development, and construction of this capital improvement and to share feedback. The final budget and timeline will depend on the chosen design, and we are committed to pursuing a cost-effective approach that prioritizes value for our residents.

### **SRCA BOARD OF DIRECTORS ANNOUNCES 2025 BUDGET/ANNUAL ASSESSMENT**

On October 10, 2024, the Stonebridge Ranch Community Association Board of Directors approved the Association's 2025 operating budget and the 2025 annual assessment.

The flat-rate 2025 annual assessment for Stonebridge Ranch homeowners is \$1,003. This is a 5.2% increase over the 2024 assessment. When planning your assessment payment, please keep these key factors in mind:

- The 2025 assessment statement will be mailed to each homeowner no later than November 1, 2024.
- The due date for your assessment payment is **January 1, 2025**.
- It is the homeowner's responsibility to ensure their payment is posted to their SRCA account on time.
- The SRCA does not accept postage mailing dates or the procedures of the homeowner's bank. Some e-check and ACH payments can take up to two weeks to be processed and posted to the SRCA account.
- If you make or mail your payment after January 1, you risk a late payment fine if the payment is not received by SRCA or GrandManors by the last day of January 2025.

Stonebridge Ranch and GrandManors offer a variety of payment options. These include:

- CiraNet Resident Portal.
- Automatic Draft (ACH) which must be set up prior to December 31, 2024.
- By calling the GrandManors Resident Service Center at 855-947-2636 to pay by e-check or credit card.
- In person at the SRCA office. *Please note that the on-site office does not accept cash.*
- Check by mail.

### **Why the Increase?**

In the fall of each year, the Board sets the subsequent year's annual assessment rate. Every year, inflation causes the costs associated with maintaining the

beautiful common areas, parks and playgrounds, lakes, trails, amenities, etc. of our wonderful community to increase. That is the Board's primary determinant in annual assessment increases.

According to SRCA governing documents, the Board of Directors is authorized to increase the annual assessment by five percent (5%) or the percentage increase of the CPI-U index from the previous fiscal year, whichever is greater. Since the previous fiscal year's CPI-U index increase of 5.2% was greater than 5%, that percentage increase was used on October 10, 2024, to set the 2025 annual assessment rate. As reported above, the SRCA Annual Assessment is \$1,003 for 2025 and it is due on or before January 1, 2025

## **BEACH CLUB 2.0 UPDATE – AND THEN THERE WERE THREE**

During the Stonebridge Ranch Community Association Board of Directors meeting on September 26, 2024, three landscape architectural and architecture firms were selected for further consideration. The next step will involve negotiations for a professional services contract. Once finalized, the firm chosen to partner with SRCA will be announced. The Board is seeking the best qualified firm to help SRCA design and create our modern Beach Club, a signature amenity that meets our community's diverse needs.

## **BEACH CLUB 2.0 UPDATE – INTERVIEWS WITH POSSIBLE FIRMS COMPLETED**

The Stonebridge Ranch Community Association Board of Directors continues to make significant strides on the new Beach Club project. This week the Board

completed interviews with the short list of selected firms. During the September 26 Board of Directors meeting, the Board plans to select a primary and back-up landscape architecture firm. Then negotiations on a professional services contract will begin to determine the final firm selection. Once that contract has been negotiated, the landscape architecture firm selected to partner with SRCA will be announced.

## **BEACH CLUB 2.0 UPDATE – SEARCH FOR LANDSCAPE ARCHITECT**

A significant first step in our creation of a modern Beach Club is the selection of a landscape architect/engineering firm to partner with SRCA. In late July, the Board of Directors released a Request for Qualifications (RFQ) to begin the search for a landscape architect. Submissions from eight firms in the form of statements of qualifications have been received and are under review. The Board's plan is to select a landscape architect this fall.

Naturally, you might wonder, "why does Stonebridge Ranch need a landscape architect? Isn't this just about building a new pool?"

At first glance, replacing a pool might seem simple, but our project goes beyond that. It's not just about replacing a facility for swimming. Our goal is to create a modern signature amenity that complements the natural beauty of our lakeside view while enhancing both the functionality and aesthetics of the Beach Club. This amenity will serve as a centerpiece for the community, designed to meet the diverse needs of our residents and add long-term value to Stonebridge Ranch.

That's where a landscape architect comes in. These professionals specialize in designing outdoor spaces that integrate seamlessly with the environment and evolve with a community's needs. Unlike a general contractor, whose main focus is construction, a landscape architect sees the full picture. They consider everything from how to design aquatic experiences and settings to making the most of nearby natural resources and selecting plants that will thrive in our Texas climate.

What truly sets landscape architects apart is their ability to think long-term. They plan for how the space will mature over time, considering the growth of trees and plants, the evolving needs of the community, and how the facilities and area will be maintained. This level of foresight not only improves the look and

functionality of the Beach Club but also enhances property values in our community. A well-designed outdoor space is an investment that benefits current residents and future generations.

After 35 years, Stonebridge Ranch continues to shine, and we want to ensure our community sustains this trend for decades to come. By hiring a landscape architect, we're not just building a pool—we're creating a space that strengthens the sense of community and enhances the quality of life for everyone who calls Stonebridge Ranch home.

### **BEACH CLUB 2.0 UPDATE – QUALIFICATION REVIEWS CONTINUE**

Work continues on the selection of the landscape architecture firm for our Beach Club 2.0 project. The Board is concluding their individual reviews of the landscape architect statements of qualifications, submitting those reviews to our General Manager, and he is assembling the results. The Board will then consider the results and discuss next steps. The goal remains to identify the landscape architecture firm to partner with SRCA by mid-to-late September.

### **BEACH CLUB 2.0 UPDATE – STATEMENTS OF QUALIFICATIONS RECEIVED**

Significant progress is being made in selecting an architectural or engineering firm to bring our new Beach Club to life! On Friday, August 23, the Stonebridge Ranch Community Association Board of Directors received Statements of Qualifications (SOQs) from eight firms eager to take on the project. The Board is now reviewing each firm's relevant experience and qualifications with plans to approve the winning firm by mid-to-late September. Key factors being considered include technical competence; demonstrated success in similar projects; and capability to perform the desired services on time and within budget.

### **BEACH CLUB 2.0 UPDATE – DEADLINE FOR SUBMISSION OF STATEMENTS OF QUALIFICATION FOR SRCA BEACH CLUB 2.0.**

Today marks the deadline for architectural and engineering firms to submit their statements of qualification for professional services related to our SRCA Beach Club 2.0. This is a key milestone for us. Each firm's statements outline their experience, expertise, and capacity to partner with SRCA in the creation of a modern Beach Club to better serve our community.

**What happens next?** After issuing the RFQ (Request for Qualifications) on July 26 and answering questions from several firms, the Board and General Manager will now dive into the review and evaluation of each firm's statement of qualifications. Over the next several weeks, we'll narrow down the top candidates and expect to select a firm by mid-to-late September. The selected firm and SRCA will begin a multi-step process starting with project initiation. Our partner firm will analyze our current Beach Club status as well as challenges and opportunities to be addressed in the design and development of a new Beach Club. Our General Manager and Board will be actively involved and, as more details are confirmed, we will be seeking resident feedback.

Through next Friday, Aug. 30, the Aquatic Center will be open Monday to Friday from 4:30 to 8:00 p.m., with weekend and Labor Day hours from 10 a.m. to 8 p.m. For early risers, lap swim is available Monday through Friday from 6 to 8 a.m. Please note, except for the early morning lap swim, the center is closed on Tuesdays for maintenance. After Labor Day, the Aquatic Center will only be open on weekends from 12 to 5 p.m., with the last day of the season being Sunday, September 29.

The APEX Centre in McKinney continues to offer a special \$7 rate for residents through Labor Day when you show your SRCA ID card! Currently, the APEX outdoor pool complex is only open on Saturdays from 12 to 6:30 p.m. and Sundays from 12 to 5:30 p.m. Labor Day is tentatively scheduled from 12 to 7:30 p.m. but those hours could change; please visit <https://www.mckinneytexas.org/1711/Facility-Pool-Hours...> for updated holiday hours before visiting the facility.

## **BEACH CLUB 2.0 UPDATE – MEETING WITH MULTIPLE ARCHITECTURAL AND ENGINEERING FIRMS**

On August 6, the Stonebridge Ranch Community Association made a significant stride toward a new Beach Club. Our General Manager and members of the Board met with multiple architectural and engineering firms. The purpose of the meeting was to provide the firms with an opportunity to ask questions prior to their respective responses to our RFQ (request for qualifications). Each respondent will provide SRCA with a Statement of Qualifications per the RFQ details.

The firms have until August 23 to submit their Statement of Qualifications. From there, the Board will review each submission, determine the two or three firms that best meet the RFQ criteria, and complete the final steps to identify a firm to partner with SRCA on the creation of a modern Beach Club: one that maximizes our multitude of beautiful spaces and meets the diverse needs of our community members.

Our goal is to choose a winning firm by mid-September. We will keep you in the loop throughout this process.

In the meantime, we hope you're soaking up the last bits of summer at our other amenities, including our Aquatic Center, which now has new hours for this school year. From August 8 to August 30, it will be open Monday to Friday from 4:30 to 8:00 p.m. and on weekends and Labor Day from 10 a.m. to 8 p.m. For our early risers, lap swim is available Monday through Friday from 6 to 8 a.m. through August 30. Except for the early morning lap swim, please note the Aquatic Center will be closed on Tuesdays for maintenance. The Aquatic Center will be open September 1 and 2 from 10 a.m. to 8 p.m. On Saturdays and Sundays in September the Aquatic Center will be open noon to 5 p.m. The

Aquatic Center will be closed weekdays in September from September 3 through 30.

The APEX Centre in McKinney is also available for SRCA resident use through Labor Day at a special rate of \$7 per person, if you show your SRCA identification card! Starting August 10, the APEX outdoor pool complex is only open Saturdays from 12 to 6:30 p.m., Sundays from 12 to 5:30 p.m., and Labor Day 12 to 7:30 p.m.

### ***Beach Club Update: July 2024***

The Stonebridge Ranch Beach Club is located at 6201 Virginia Parkway. For more than 35 years, this original amenity--including an iconic beach and swim lagoon and overlook to beautiful Stonebridge Lake--served up family fun!

In the course of regular pool maintenance, we had a leak detection survey done by On The Spot Leak Detection. It revealed a significant loss of water on a daily basis. This loss is both financially and environmentally unacceptable, and repairs to the pool were not feasible.

So, after decades of service, the Stonebridge Ranch Beach Club swim lagoon was drained on July 7, 2024, setting the ball in motion for a new Beach Club pool facility.

Details are in development for the new version of the Beach Club; but rest assured it will be a fitting successor to the original!

The renovation of our signature Beach Club is underway. We kicked off the process on July 7th by draining the Beach Club pool. The pool was closed earlier than expected, but we are excited to announce that the hours at our Aquatic Center have been extended – a decision made with your needs in mind!

Aug. 1, 2, 3, 4, 5 & 7: 10 am – 8 pm open swim

August: 8 – 30 NEW weekday hours are 4:30 pm – 8:00 pm for open swim; as previously posted: 6 am – 8 am M-F for lap swim.

Weekends: Hours are 10 am – 8 pm for Saturday/Sunday weekend swim in August.

#### **September Schedule**

Sept. 1- 2 (Labor Day) hours are 10 am – 8 pm for open swim;

Sept. 3 – 30 weekdays the Aquatic Center Pool is closed.

Weekends: September Saturday and Sunday hours are noon to 5 pm.

The Aquatic Center pool is closed every Tuesday for cleaning.

We hope these extended hours will allow everyone to make the most of summer fun at Stonebridge Ranch! As we finalize the details and timeline for our new state-of-the-art Beach Club, we will keep you updated through email, on our website, and official Facebook page.

## **2024 BEACH CLUB CLOSURE DATE**

The Stonebridge Ranch Community Association believes our residents deserve a community with premier amenities, which is why we take thorough and careful consideration in our decisions, especially when it may affect residents. On June

18, the Board of Directors reviewed the Beach Club Pool leak detection results and subsequent water loss report by On The Spot Leak Detection. These findings confirmed the Beach Club pool is losing 130 gallons of water per minute or 187,200 gallons per day, due to the overall age of the pool and related infrastructure. This is unacceptable because our community deserves the very best amenities that use a resource as precious as water thoughtfully.

Although the Board and staff had hoped to keep the Beach Club pool open throughout the 2024 pool season, this extreme water loss caused by erosion and age cannot continue. To ensure our next-generation Beach Club is ready for the 2025 pool season and to protect the next generation of our community, we must begin repairs as soon as possible.

After much due diligence, we have made the tough decision to close the Beach Club pool for the remainder of the summer at the end of pool hours on July 7. If there are significant weather or maintenance issues before July 7, regrettably, we may have to close the Beach Club sooner. Stonebridge Ranch is committed to upholding its status as McKinney's premier living destination, with the Beach Club being our most prominent attraction for over 35 years.

The Board will vote on June 27 to begin the design process for the next-generation Beach Club. With this late June vote, we anticipate a May 2025 opening of our new signature amenity. We will keep you informed during the design, planning, development, construction, and grand reopening processes. It will be a busy 10 months at the Ranch!

The Board of Directors for Stonebridge Ranch Community Association has approved a new Administrative Collection Fee of \$25.00 per month for any homeowner account with an outstanding balance of \$25 or more at the end of any calendar month that has been posted for at least 30 days. The new fee will help defray costs to collect these delinquent accounts and, currently, those costs are absorbed by all SRCA owners. However, the new fee will not apply if the delinquent homeowner is up to date on payments per an approved payment plan.

The effective date for the new fee is August 1, 2024. The new fee will be billed directly to the homeowner and will only be charged if an account is delinquent.

Beginning on the effective date, any homeowner with a balance of \$25 or more that has been posted for at least 30 days will be charged an additional \$25 each month until the account balance is paid in full.

The Board of Directors encourages all homeowners to take a moment to review their account before August 1, 2024.
